Requesting investigation for alleged misuse of Public Funds and Abuse of Power

The Programme for the Protection of Public Resources (PPPR) and Advocacy and Legal Advice Centre (ALAC) - of Transparency International Sri Lanka (TISL) has received a number of complaints regarding the misuse of public funds and abuse of power by public officials. Under the same initiative, we submitted 4 complaints on 8th June 2018. With this letter, we are submitting 3 further complaints for your investigation with supportive documentation such as investigation reports, official letters, internal Audit reports and documents received from public authorities through RTI.

We are of the view that these matters could amount to offences under Section 70 of the Bribery Act. We are therefore officially filing this complaint with CIABOC, as the sole entity empowered to initiate action under the Bribery Act. TISL requests CIABOC to exercise its powers under Article 156A (1) (b) of the Constitution to ensure that these complaints are investigated and that prosecutions are undertaken where necessary.

Hereby respectfully requesting investigation into the following matters:

Complaint 1: North East Local Services and Infrastructure Project (NELSIP) – Misappropriation by Engineer- Planning and Contractors

According to the attached report of by the committee appointed by the Northern Provincial Council to investigate the corruption and misappropriation of funds under the NELSIP, it has been alleged that a sum of Rs. 4.34 million has been misappropriated by an Engineer- Planning, in collusion with the contractors during the period 2013 to 2015.

Complaint 2: Abuse of power by former Chief Minister, North Western Province

We have obtained a number of copies of letters bearing the signature of the former Chief Minister of the North Western Province signed on 10 December 2013, during his term of office, directing four school principals to carry out admissions in violation of the relevant circulars on school admissions and transfer of students. Complaint 3: Allegations of misappropriation by officials at Provincial Road Development Authority, North Central Province

We have obtained a number of letters dated between 2012 and 2016 concerning a large sum of public funds allocated for road construction, which has been allegedly misappropriated by the officers of the authority. According to the General Manager of the Provincial Road Development Authority, the total sum misappropriated is in excess of 37.5 million rupees. No action has been taken to recover the amounts, despite two officers being suspended. The present General Manager has also complained that he has faced severe threats due to the disclosure of this misappropriation. There are also documents from the Auditor General's Department Audit query, which confirms that—loss has been caused through irregularities which need to recovered from the individuals concerned.

We have also received documentation which shows that one of the officials against whom disciplinary action was taken has been reinstated.
